AN ORDINANCE CHANGING THE CLASSIFICATION OF THE CITY OF UHLAND, TEXAS, FROM THAT OF A TYPE B GENERAL LAW MUNICIPALITY TO THAT OF A TYPE A GENERAL LAW MUNICIPALITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UHLAND:

Section 1. The City Council hereby finds that at least one manufacturing establishment is contained within its corporate limits.

Section 2. The City of Uhlend is hereby changed from a Type B general law municipality to a Type A general law municipality in accordance with the powers granted it by the Texas Local Government Code.

Section 3. This Ordinance shall be signed by the Mayor, Attested by the City Secretary under the Corporate Seal of the City, and filed in the Ordinance Book of the City. Copies of this Ordinance shall be signed by the Mayor, Attested by the City Secretary under the Corporate Seal of the City, and a copy shall be filed and recorded in the office of the County Clerks of Hays and Caldwell Counties, Texas.

PASSED and approved at a regular meeting of the Board of Aldermen of the City of Uhlend, Texas, held on September 2, 1987, by a vote of 5 FOR and 0 AGAINST adoption, being a vote of more than two-thirds FOR of the governing body.

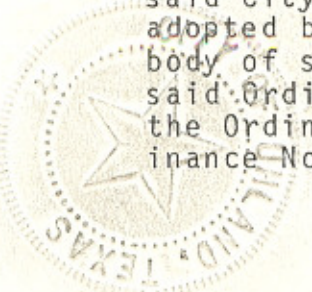

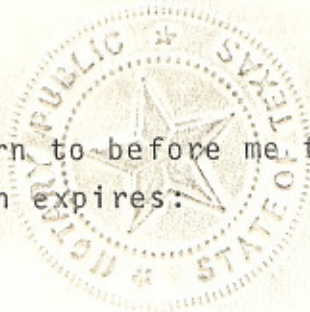
