Whereas, a petition has been presented to the Board of Aldermen of the City of Uhlund, Texas, asking for annexation of a tract of land that is adjacent and contiguous to the City Limits; and

Whereas, all persons having an ownership interest in said tract of land have signed the petition;


NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UHLAND, TEXAS:

Section 1. That the tract of land described in said petition shall be, and it is hereby, annexed to the City of Uhlund, Texas, for all purposes.


Section 2. That the Board of Aldermen finds that all prerequisites have been satisfied, and that no legal impediment exists to prevent said annexation.
