

ORDINANCE NO. 94

AN ORDINANCE CANVASSING THE RETURNS OF AN ELECTION OF ONE (1) MAYOR UNEXPIRED TERM AND THREE (3) COUNCIL MEMBERS FOR FULL TERM.

WHEREAS, an election was held in the City of Umland, Texas on May 9, 2009 for the purpose of the election of one (1) Mayor unexpired term and three (3) councilmember's for full term; and

WHEREAS, the City Council has reviewed and investigated all matters pertaining to this election, including the ordering, notices, election officers, holding and returns thereof; and

WHEREAS, the City Council hereby canvasses the returns of this election, at which there was submitted to all resident, qualified electors of the City for their action thereupon, the election of one (1) mayor unexpired term and three (3) council members for full term; and

WHEREAS, The City of Umland has diligently inquired into the polls lists and the official election returns which were duly and lawfully made to this City Council by the judges and clerks holding and conducting the election; the poll lists and the official election returns showing separately the votes cast in the election ;and

WHEREAS, from these returns, this City Council hereby finds that the following votes were cast in the election by voters who where resident, qualified electors of the City of Umland; and

WHEREAS, each of the candidates in said election received the following votes:

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UHLAND THAT:

SECTION 1. The City Council officially finds, determines, and declares that the election was duly and properly ordered, that proper legal notice of such election was duly given in English language and Spanish language, that proper election officers were duly appointed prior to the election, that the election was duly and legally held, all the resident, qualified electors of the City of Uhlend were permitted to vote at the election, and due returns of the results of the election had been made and delivered, and that the City of Uhlend has duly canvassed such returns, all in accordance with the laws of the State of Texas and the United States of America and the resolution calling the election.


