

ORDINANCE NO. 141

AN ORDINANCE AUTHORIZING THE PARTIAL RELEASE OF AREA FROM THE CITY OF UHLAND EXTRATERRITORIAL JURISDICTION ("ETJ") TO THE CITY OF SAN MARCOS IN EXCHANGE FOR THE CITY OF SAN MARCOS' PARTIAL RELEASE OF AREA FROM SAN MARCOS' ETJ TO THE CITY OF UHLAND; ESTABLISHING AGREED ETJ BOUNDARIES WITH THE CITY OF SAN MARCOS, TEXAS; AUTHORIZING THE EXPANSION OF UHLAND'S ETJ, AND ESTABLISHMENT OF AN AGREED SAN MARCOS-UHLAND ETJ BOUNDARY; ESTABLISHING A REVISED ETJ BOUNDARY LINE FOR UHLAND; AUTHORIZING THE MAYOR OR MAYOR PRO TEM TO EXECUTE ANY AND ALL DOCUMENTS FOR APPROVAL AND IMPLEMENTATION OF THIS ORDINANCE; PROVIDING FOR AN EFFECTIVE DATE; AND PROVIDING FOR SEVERABILITY.

RECITALS:

1. In 2007 the City Council of the City of San Marcos declared its population in excess of 50,000 in Resolution 2007-132. TEXAS LOCAL GOVERNMENT CODE SECTION 42.021(A)(3) provides that cities with a population of 50,000 to 99,999 have an Extraterritorial Jurisdiction ("ETJ") of three and one-half (3 ½) miles and
2. The City of Uhlend desires to release from its ETJ approximately 209.9 acres south of Misty Road and east of Hwy 21 more particularly described in Exhibit "A" attached hereto and incorporated herein for all purposes that may be included in San Marcos' ETJ; and
3. The City of San Marcos desires to release from its ETJ approximately 1,714.4 acres on the east side of State Hwy 21 adjacent to the intersection of Misty Road more particularly described in Exhibit "B", attached hereto and incorporated herein for all purposes that may be included in Uhlend's ETJ.
4. The City Council of the City of San Marcos desires to release a portion of its ETJ to the City of Uhlend in exchange for the City of Uhlend's release of a portion of its ETJ to San Marcos and to establish an "Agreed ETJ Boundary" with the City of Uhlend, Texas; and
5. Agreements regarding areas adjacent to the cities' respective extraterritorial jurisdiction will assist and enhance the planning for development and capital improvement programs and services.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UHLAND, TEXAS:

SECTION 1. Findings. All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of Uhlend, and are hereby approved and incorporated into the body of this Ordinance as if copied in their entirety.

SECTION 2. Release and Inclusion of Area in ETJ; Filing and Display.

1. That the City Council of the City of Uhlend hereby approves the release of a portion of its ETJ (hereafter "Uhlend Release Area") as described in Exhibit "A"; and

2. Upon San Marcos' release of the appropriate area from the San Marcos ETJ, (hereafter, the "San Marcos Release Areas") and voluntary annexation by each property owner of the San Marcos Release Areas such area shall be included and for all purposes brought within the boundaries of the City of Uhland's ETJ, and made an integral part, thereof, subject to the terms and conditions of the Agreement; and
4. That this Ordinance does not apply to any portion of the Uhland Release Area that is currently within the ETJ of another municipality and for which consent has not been or will not be granted by the releasing municipality. Any portion of the Areas that is not released from another municipality's ETJ is expressly excluded from this Ordinance. This Ordinance shall not be construed to in any way alter, modify or revise the ETJ of any municipality other than the City of Uhland.
5. That the official map and boundaries of the City of Uhland is hereby amended and revised to exclude the Uhland Release Areas.
6. That the owners and inhabitants of the areas are entitled to all of the rights and privileges of other citizens of the City of Uhland's ETJ, and are hereby bound by all acts, ordinances and other legal actions now in full force and effect, and those that may be hereafter adopted or enacted, regarding the ETJ.
7. That the City Clerk is hereby instructed to include this Ordinance in the records of the City.
8. That the Mayor or Mayor Pro Tem is hereby instructed to file a certified copy of this Ordinance and attachments with the Caldwell County Clerk and other appropriate entities.
9. That the City Administrator is hereby instructed to have maps depicting the new municipal boundaries prepared.
10. That the Mayor or Mayor Pro Tem is hereby authorized to execute any documents necessary for the approval and implementation of this Ordinance between the City of Uhland and the City of San Marcos, and the expansion of Uhland's ETJ.

SECTION 3. Effective Date. This Ordinance is effective and shall be final and complete after the date of final execution of this Ordinance by an authorized official of the City of Uhland and final action by the City of San Marcos releasing the approximate 1,714.4 acres from the City of San Marcos's ETJ.

SECTION 4. Severability. It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs and sections of this Ordinance be severable. If any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional or *ultra vires* by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality or illegality shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this Ordinance, and the remainder of this Ordinance shall be enforced as written. The voiding by a court of any ETJ expansion previously approved by the City of Uhland shall not be construed in any way to affect any other ETJ expansion by the City.

SECTION 5. Proper Notice and Meeting. It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public as required and that a public notice of the time, place and purpose of said meeting was given as required by the OPEN MEETINGS ACT, CHAPTER 551 OF THE TEXAS GOVERNMENT CODE.

THENCE, S48°23'11"W, leaving the easterly line of Misty Line, over and across Misty Lane and along the southerly line of said Tax Parcels 16429, 16399 and 16428, continuing over and across the Thomas Yates Survey, Abstract No. 313, for the southerly line hereof, a distance of 2053.78 feet to the southwesterly corner of Tax Parcel No. 16428, being the southwesterly corner of said 209.9 acres, for the southwesterly corner hereof;

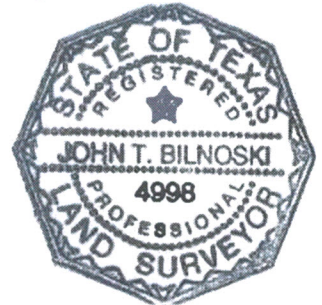

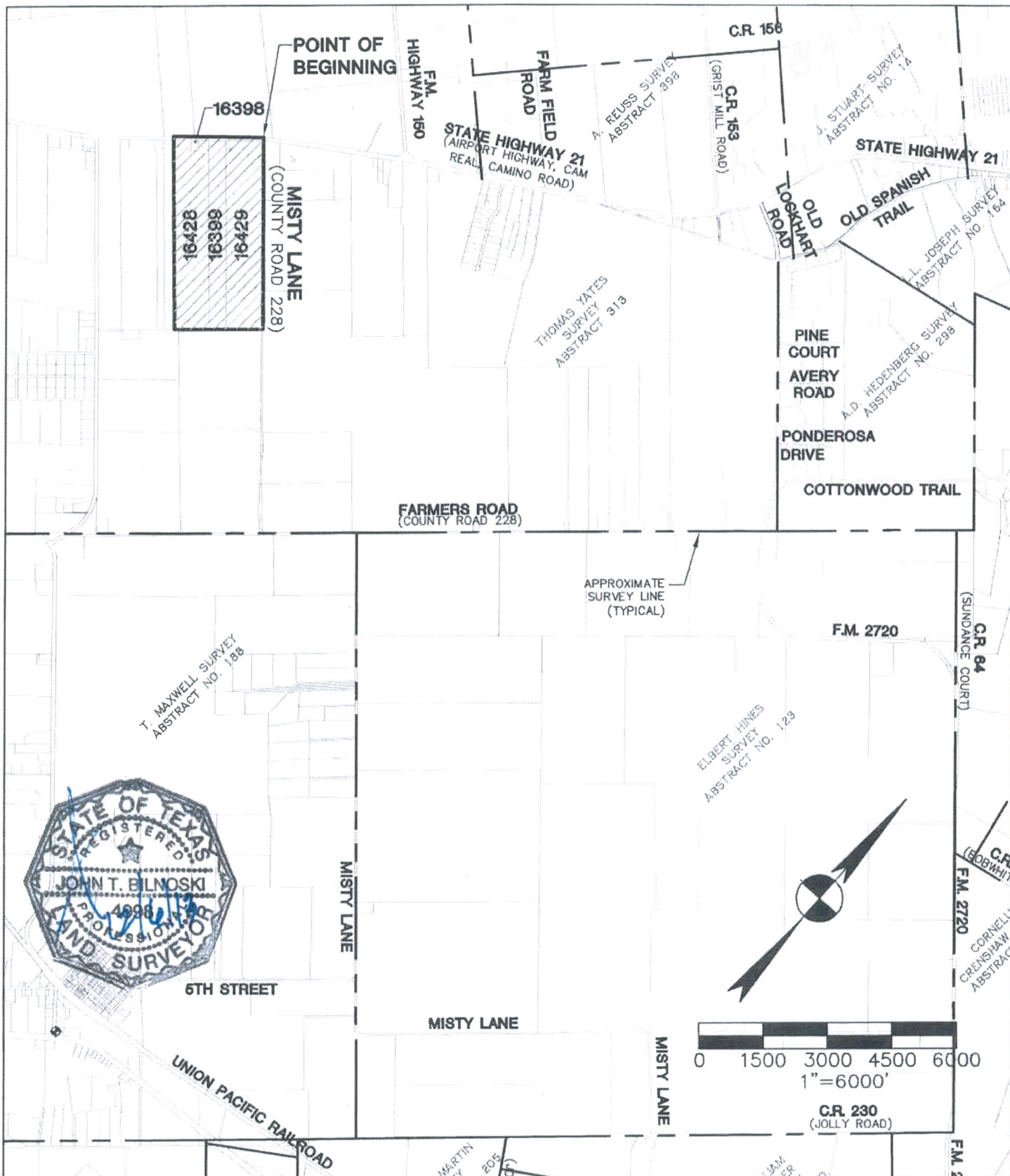

BEGINNING, at a point in the northerly line of State Highway 21 and the intersection of the prolongation of the easterly line of Misty Lane, being the most northwesterly corner hereof;

THENCE, along the northerly line of State Highway 21, for the northerly line hereof, the following two (2) courses and distances:

- 1) N56°41'13"E, a distance of 3528.52 feet to an angle point;
- 2) N61°24'02"E, a distance of 2352.44 to a point of curvature of a non-tangent curve to the left, for the northeasterly corner hereof;

THENCE, leaving the northerly line of State Highway 21, over and across State Highway 21 and also over and across said Thomas Yates Survey, for a portion of the irregular easterly line hereof, the following four (4) courses and distances:

- 1) Along a non-tangent curve to the left, having a radius of 2681.00 feet, a central angle of 58°47'15", an arc length of 2750.80 feet, and a chord which bears, S56°17'37"E, a distance of 2631.72 feet to the end of said curve, for the end of said curve;

- 2) S38°50'28"E, a distance of 921.61 feet to an angle point;
- 3) S41°35'49"E, a distance of 1600.60 feet to the point of curvature of a non-tangent curve to the right;
- 4) Along said curve having a radius of 18465.00 feet, a central angle of 39°16'59", an arc length of 12659.99 feet, and a chord which bears, S21°34'40"E, a distance of 12413.48 feet to a point in the easterly line of Misty Lane, for the most southerly corner hereof;


THENCE, N41°30'45"W, along the easterly line of Misty Lane, for a portion of the westerly line hereof, crossing Farmers Road, a distance of 8716.77 feet to a point in the northerly line of Farmers Road, for an angle point hereof;

THENCE, S48°02'13"W, along the northerly line of Farmers Road, for a portion of the westerly line hereof, a distance of 2206.02 feet to a point at the intersection of the easterly line of Misty Lane with the northerly line of Farmers Road, for an angle point hereof;

THENCE, N41°22'22"W, leaving the northerly line of Farmers Road, along the easterly line of Misty Lane, for a portion of the westerly line hereof, a distance of 9065.04 feet to the **POINT OF BEGINNING**, containing an area of 1714.4 acres of land, more or less, within these metes and bounds.

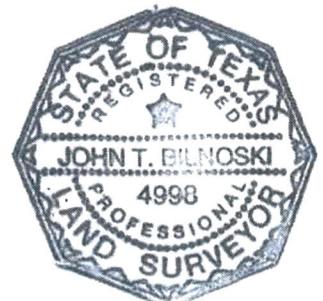
