ORDINANCE NO. 226

ETJ EXPANSION ORDINANCE

AN ORDINANCE OF THE CITY OF UHLAND TEXAS, EXPANDING THE CITY'S EXTRATERRITORIAL JURISDICTION (ETJ) AND AMENDING/CORRECTING ORDINANCE NO. 215. SO AS TO INCLUDE ADJACENT AND CONTIGUOUS TERRITORY UPON THE VOLUNTARY ANNEXATION PETITION OF THE PROPERTY OWNER, INCLUDING THE FOLLOWING: BEING 13.57 ACRES OF LAND, MORE OR LESS, OUT OF THE LEWIS L. JOSEPH SURVEY, ABSRTRACT NO. 164, SITUATED IN CALDWELL COUNTY, TEXAS, BEING A PORTION OF THAT 148.88 ACRE TRACT OF LAND CONVEYED TO DOUGLAS A. BENDER, TRUSTEE OF THE TIFFANY COLEMAN TRUST UNDER TRUST AGREEMENT DATED OCTOBER 11, 2016 BY DOCUMENT NO 06033332, RECORDED IN VOLUME 3043, PAGE 609, OFFICIAL PUBLIC RECORDS, CALDWELL COUNTY, TEXAS (O.P.R.C.C.TX.), SAID 13.57 ACRES BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS

WHEREAS, Chapter 42 of the Texas Local Government Code authorizes municipalities to expand their ETJs upon request of the property owner if that territory is adjacent and contiguous to the present ETJs; and

WHEREAS, the property owner requested that the City of Uhland include within the City's ETJ, the territory that is more particularly described by **EXHIBIT "A"** (hereafter referred to as the "Territory"); and

WHEREAS, the Territory is contiguous to the City's ETJ and

WHEREAS, at the conclusion of the hearing, the Uhland City Council determined that the Territory and the petitioner satisfy all requirements for inclusion with the City's ETJ and that granting the petition is in the public interest of the citizens of the area and Uhland.

NOW THEREFORE, BE IN ORDAINED BY THE CITY COUNCIL OF THE CITY OF UHLAND:

1. FINDINGS OF FACT

All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council of the City of Uhland and are hereby approved and incorporated into the body of this as if copied in their entirety.

2. INCLUSION OF AREA IN ETJ

- A. The petition attached hereto as Exhibit "A" is hereby approved and granted.
- B. The ETJ of Uhland is hereby expanded so as to include the Territory. The Territory is hereby included and for all purposes brought within the boundaries of the City of Uhland's ETJ and is made an integral part thereof.
- C. This Ordinance does not apply to any portion of the Territory that is currently within the ETJ of another municipality and for which consent has not been granted by the releasing municipality. Any portion of the Territory that is within another municipality's ETJ is expressly excluded from this Ordinance. This Ordinance shall not be construed to in any was alter, modify, or revise the ETJ of any municipality other than the City of Uhland.
- D. The official map and boundaries of the City are hereby amended and revised so as to include the Territory.
- E. The owners and inhabitants of the Territory are entitled to all of the rights and privileges of other citizens of the City's ETJ and are hereby bound by all acts, ordinances, and other legal actions now in full force and effect and those that may be hereafter adopted or enacted regarding the ETJ.

3. FILING & DISPLAY

- A. The City Secretary is hereby instructed to include this Ordinance in the records of the City.
- B. The Mayor is hereby instructed to file a certified copy of this Ordinance and attachments with the County Clerk of Caldwell County, Texas, and other appropriate entities.
- C. The City Engineer is hereby instructed to have maps depicting the new municipal boundaries of the City prepared

4. EFFECTIVE DATE

This Ordinance is effective and the expansion of the ETJ achieved herein shall be final and complete upon the adoption of the Ordinance.

5. SEVERABILITY

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs and sections of this Ordinance be severable. If any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional or *ultra vires* by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality or illegality or illegality shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this Ordinance, and the reminder of this Ordinance shall be enforced as written. The voiding by a court of any ETJ expansion previously approved the City of Uhland shall not be construed in any way to affect any other ETJ expansion by the City.

6. PROPER NOTICE AND MEETING

It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code

PASSED AND APPROVED on this 17th day of April 2019, by a vote of Ayes, Nays and Abstentions of the City Council.

BENDER, TRUSTEE OF THE TIFFANY COLEMAN TRUST UNDER TRUST AGREEMENT DATED OCTOBER 11, 2006 BY DOCUMENT NO. 06033332, RECORDED IN VOLUME 3043, PAGE 609, OFFICIAL PUBLIC RECORDS, CALDWELL COUNTY, TEXAS (O.P.R.C.C.TX.), SAID 13.57 ACRES BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS;

COMMENCING at a set iron rod with cap stamped "SPOT ON SURVEYING", being set as a point in the Southeasterly Right of Way line of State Highway 21, (A.K.A. Camino Real) 100 foot wide, and for the most Northerly corner of said 148.88 acre tract of land;

THENCE S 10° 44' 34" E, 3324.57 feet leaving said Right of Way with the Easterly limits of said 148.88 acre tract to a point of intersection with a curve, said curve being concave Northwesterly having a radius of 2640 feet, and being the existing City of Uhland ETJ limits, for the TRUE POINT OF BEGINNING hereof, said City ETJ limits being established 1/2 mile or (2640 feet) from the existing City limits of Uhland, said City limits being established at the intersection of the center of Brushy Creek and said Southeasterly Right of Way line of S.H. 21;

THENCE with the Easterly, Southeasterly and Southerly limits of said 148.88 acre tract the following four (4) courses;

- 1. S 10° 44' 34" E, 1265.33 feet to a found 1/2 iron rod;
- 2. S 48° 35' 06" W, 439.02 feet to a found 60d nail in a fence post;
- 3. N 86° 56' 04" W, 223.78 feet to a found fence post
- 4. N 88° 05' 05" W, 439.42 feet to a point of intersection with said curved City of Uhland ETJ limits;

THENCE leaving said Southerly limits through the interior of said 148.88 acre tract Northeasterly with said City of Uhland ETJ limits along said curve to the left through a central angle of 37° 14' 30", an arc length of 1715.98 feet to the Point of Beginning hereof, having a chord bearing and distance of N 26° 38' 34" E, 1685.93 feet to said point, containing a calculated area of 591,093.63 sq. ft., 13.57 acres, said field notes being described in accordance with a survey made on the ground by me or under my direction and Exhibit "B" Survey Sketch attached hereto and made a part hereof. All bearings shown are based on NAD 83 Texas State Plane Coordinate System, South Central Zone. All distances shown are surface or ground distances.


