B. PUBLIC COMMENTS

Inquiries about matters not listed on the agenda will either be directed to City Staff or placed on a future agenda for Council consideration. **No discussion or formal action will be taken at this meeting on items discussed by a speaker during public comment.**

Citizens are welcome to comment on posted agenda items at the time when called for discussion. A speaker must submit a Public Comment Form to the City Administrator *prior to* the start of the meeting and indicate the item the speaker will address. A speaker will be allowed three (3) minutes to comment on the agenda item when called.

PUBLIC HEARING

Public Hearing to review the program performance of the activities completed under the Texas Community Development Block Grant for sidewalk improvements on North Old Spanish Trail and explain the actual use of the Texas Community Development Block Grant Program funds.

Reconvene: The City Council will reconvene in open session for action, if any, on items discussed in Executive Session.


F. ANNOUNCEMENTS
