#### **ORDINANCE NO. 159**

AN ORDINANCE ANNEXING LAND ADJACENT AND CONTIGUOUS TO THE CITY OF UHLAND, TEXAS FOR ALL PURPOSES. BEING A 0.2019 ACRE TRACT OF LAND OUT OF THE THOMAS B WESTB ROOK SURVEY, A-468, SAME BEING A PORTION OF HAYS COUNTY ROAD NO. 127 (HIGH ROAD), A VARIABLE WIDTH PUBLIC RIGHT-AWAY, AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS AS "EXHIBIT B".

**WHEREAS**, a petition has been presented to the Board of Aldermen of the City of Uhland, Texas, asking for annexation of Hays County Road known as High Road adjacent and contiguous to the City Limits of the City of Uhland, Texas, and;

WHEREAS, the county will be responsible for maintaining said road.

## NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UHLAND, TEXAS:

**Section 1.** That the tract of land described in said petition which is attached as "Exhibit B", and which is hereby incorporated by reference, shall be and it is hereby, annexed to the City of Uhland, Texas, for all purposes.

**Section 2.** That the City Council finds that all prerequisites have been satisfied, and that no legal impediment exists to prevent said annexation.

**Section 3.** That the legal description of all annexed property shall be filed with this ordinance, as a part hereof, and that the map of the City limits shall be amended to show the property annexed as a part of the City

**COMMENCING** at a 1/2" iron rod found in concrete at a corner clip at the intersection of the northwest line of Texas State Highway No. 21 (100 foot public right-of-way), with the northeast line of Hays County Road No. 127 – High Road (variable width right-of-way), for the southeasterly corner of that certain called (5.100) acre tract as conveyed to B B & C Properties, a Texas general partnership, by deed recorded under County Clerk's File No. 9929085 of the Official Public Records of Hays County, Texas;

**THENCE South 85°08'10" West** (S 85°59'00" W Record), along said corner clip and the northeast line of said Hays County Road No. 127 (High Road), a distance of **112.94 feet** (113.25' Record) to a 1/2" iron rod found;

**THENCE North 46°36'54" West** (N 44°38'11" W Record), continuing along the northeast line of said Hays County Road No. 127 (High Road), a distance of **216.74 feet** to the intersection of the northeast line of said Hays County Road No. 127, with a northwest City Limit line of the City of Uhland, according to the Map & Description of "Tract A" as adopted by the City of Uhland Board of Aldermen May 3, 2006, same being 300 feet northwest of the northwest line of the afore-mentioned Texas State Highway No. 21, and being in the arc of a curve, for the **POINT OF BEGINNING** and the east corner of the herein described tract of land:

**THENCE** crossing said County Road No. 127 (High Road), along and with the said City Limit line, Southwesterly, **51.23 feet** along the arc of said curve, to the right, having a radius of **5374.02 feet**, a delta angle of **00°32'46"** and a chord which bears **South 36°57'23"** West, a distance of **51.23 feet** to a corner of said City Limits called "Tract A", for the south corner of the herein described tract of land, same being in the northeast line of that certain called (0.574) acre tract of land dedicated to the Hays County Commissioners Court for widening, as recorded in Volume 1401, Page 576 of the Official Public Records of Hays County, Texas, and as shown by map of Camino Crest Section Two, an addition to Hays County, recorded in Volume 11, Page 242 of the Plat Records of Hays County, Texas;

**THENCE North 46°16'56"** West, continuing along the City Limits and a northeast line of said Tract A and the northeast line of said (0.574) acre tract dedicated for widening, a distance of **173.45 feet** to the west corner of the herein described tract of land;

**THENCE North 34°27'09"** East, crossing said County Road No. 127 (High Road), a distance of **50.51 feet** to a 5/8" iron rod with cap found at the west corner of the aforesaid BB&C called 5.100 acre tract, for the north corner of the herein described tract of land, same being at a common corner of that certain called 82.236 acre tract conveyed to ASAAWP, LP, a Texas limited partnership by deed recorded in Volume 4618, Page 769 of the Official Public Records of Hays County, Texas, and from which a 1/2" iron rod found at an interior corner of said ASAAWP, LP 82.236 acre tract and the north corner of said BB&C called 5.100 acre tract, bears North 34°27'09" East (N 36°29'00" E Record), a distance of 473.95 feet (474.02' Record);

**THENCE South 46°36'54"** East (S 44°38'11" E Record), along the northeast line of said County Road No. 127 (High Road) and the common southwest line of said BB&C called 5.100 acre tract, a distance of **175.55 feet** to the **POINT OF BEGINNING** and **CONTAINING 0.2019 ACRES OF LAND**.


