

ORDINANCE NO. 262

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF UHLAND, TEXAS; APPOINTING AMY LEA SJ AKERS TO SERVE AS THE CITY ATTORNEY FOR THE CITY OF UHLAND, TEXAS; PROVIDING FOR: REPEAL OF CONFLICTS, SEVERABILITY, A SAVINGS CLAUSE, MEETING OPEN TO THE PUBLIC AND AN EFFECTIVE DATE.

WHEREAS, the City of Umland, Texas is a Type A general law City incorporated and functioning as such under the provisions of Chapter 11, Title 28, Revised Civil Statutes of Texas, 1925, as amended; and

WHEREAS, Section 22.071 of the Texas Local Government Code provides that a Type a general-law municipality may appoint municipal officers by ordinance; and

WHEREAS, Section 22.072 of the Texas Local Government Code provides that the City Council of the City of Umland, Texas may require a municipal officer whose duties are prescribed by the Texas Local Government Code to perform additional duties; and

WHEREAS, On March 3rd, 2021 the City Council of the City of Umland, Texas approved a contract authorizing Amy Lea SJ Akers to serve as the contract City Attorney and providing the terms of service; and

WHEREAS, On April 7th, 2021 the City Council of the City of Umland, Texas created the Office and Position of City Attorney by Ordinance No. 262; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF UHLAND, TEXAS:

SECTION 1. APPOINTMENT.

The City Council of the City of Umland, Texas hereby appoints Amy Lea SJ Akers to serve as the City Attorney for the City of Umland, Texas from the effective date of this Ordinance until removed by Ordinance. The contract between the City of Umland, Texas and Amy Lea SJ Akers approved by the City Council on March 3rd, 2021 authorizing Amy Lea SJ Akers to serve as the contract City Attorney and providing the terms of service is attached hereto, and the provision thereof shall be incorporated herein for all purposes and read as though they were written directly into this Ordinance.

SECTION 2. CONFLICT.

All Ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 3. SEVERABILITY.

If any section, subsection, paragraph, clause, phrase, or provision of this ordinance or the application of any section, subsection, paragraph, clause, phrase, or provision to any person or

circumstance is adjudged to be invalid, the invalidity shall not affect other section, subsection, paragraph, clause, phrase, or provision or applications thereof which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

SECTION 4. SAVINGS CLAUSE.

This Ordinance shall remain in full force and effect, save and except as amended or repealed.

SECTION 5. MEETING OPEN TO PUBLIC.

It is hereby found and determined that the meeting at which this Ordinance is passed is open to the public as required by law and that the public notice of the time, place and purpose of said meeting was given as required.

SECTION 6. EFFECTIVE DATE.

This Ordinance shall be effective upon passage and approval.


